

Earning the CFA Charter: The Gold Standard



Enrollment Criteria and Requirements

To become a CFA charterholder you must **enrol in CFA Program and register for the Level I exam**. In order to enrol you must meet all of the qualifications listed below:

1. Meet **one** of the following enrolment requirements:

(a) Complete a bachelor's or equivalent program

(b) Your selected exam window must be <u>23 months or fewer*</u> before your graduation month for your bachelor's degree or equivalent program


(c) Have a combination of 4,000 hours of work experience and/or higher education that was acquired over a minimum of three sequential years and achieved by the date of registering for the Level I exam

- 2. Have an international travel passport
- 3. Be prepared to take the exams in English
- 4. Meet the Professional Conduct Admission Criteria (attest compliance)
- 5. Live in a participating country (check OFAC sanctions)

The CFA Equation






*Evaluating or applying financial, economic, and/or statistical data as part of the investment decision-making process; supervising persons who conduct such activities; or teaching such activities. At least 50% of time should be spent directly involved in the investment decision-making process or producing a work product that informs or adds value to that process. Work must be full time and can be earned before, during, or after participation in the CFA Program.







*that are not part of universal or commercial banks


